One of my forthcoming publications is an academic book "*Migrant TikTok: The Struggle for Digital Power*" under contract with Fernwood Publishing due to publish in early 2026. As knowledge mobilization is core to my work, I have made 153 public appearances in television, radio and print. In terms of funding, I have received 30 research grants, 3 teaching grants, and 27 awards and scholarships totaling over \$8.2 million. Most notable is the \$3.17 million New Frontiers in Research Fund grant (Co-PI) that examines climate change adaptation, dispossession and displacement in the Philippines, Bangladesh, and Ghana.
